

# California Health Plans Are Required to Share Health Information in Real-Time through the CalHHS Data Exchange Framework (DxF).

#### What is AB 133?

AB 133 is a California state law that requires most California health care organizations, including health plans, to exchange or provide access to health information with each other in real-time for treatment, payment, or health care operations (TPO) through the CalHHS DxF.

#### What is the DxF?

The DxF comprises a single Data Sharing Agreement (DSA) and common set of Policies and Procedures (P&Ps) that governs the exchange of health and social services information among healthcare entities and government agencies as of January 31, 2024.

The DxF and DSA were developed with input from a broad set of stakeholders, including California Association of Health Plans and Local Health Plans of California, as well as nonprofit health information organizations like Manifest MedEx (MX), California's largest health data network.

More than 4,000 organizations have signed the DSA!

# Data Elements To Be Exchanged Under the DxF\*

Health Plans, including but not limited to health care service plans and disability insurers that provide hospital, medical, or surgical coverage that are regulated by the Department of Managed Health Care or the Department of Insurance, Medi-Cal managed care plans, shall provide access to or exchange, at a minimum, the data required to be shared under the Centers for Medicare and Medicaid Services Interoperability and Patient Access regulations for public programs as contained in United States Department of Health and Human Services final rule CMS-9115-F, 85 FR 25510 including, but not limited to, adjudicated claims, encounter data and clinical data as defined in the USCDI if maintained by the entity.

#### Which health plans will need to sign the DSA?

All commercial, Covered California, and Medicaid Managed Care plans regulated under the Department of Managed Health Care (DMHC) and California Department of Insurance (CDI) were required to sign the DSA and meet the data sharing requirements by January 31, 2024. Medicare Advantage plans should seek counsel on whether they are required under the law to participate.


#### Manifest MedEx: A California Health Data Network with National Connectivity

#### Securely exchange DxF required data,

Manifest MedEx regularly aggregates, normalizes, matches, and shares claims, encounter, and clinical data – as required of health plans by AB 133.

- Adjudicated claims
- Encounter information from capitated providers
- Clinical data as defined by USCDI v2, including laboratory results when maintained by the impacted payer

Claims, encounter, and clinical information is exchanged in a wide variety of nationally adopted technical standards that comply with the DxF requirements.



# With other DSA Signatories,

This health data is easily accessible to other participants of the DxF through a range of data services and our web-based longitudinal health record application, MX Access. In addition, MX makes this information available through required DxF transaction pattern standards via eHealth Exchange, a "network of networks" that makes it easy for health systems and health data networks to request and retrieve records from each other on behalf of their participating health care organizations.



# For required and permitted uses only.

The data shared through MX on an individual is accessible to permitted HIPAA-covered entities, their business associates, and compliant DSA signatories for treatment, payment, and healthcare operations (TPO) or because of a public health relationship with that individual.

Manifest MedEx is a local partner in every county throughout California, working on the ground with communities across the state. Health care is local, and health plans can depend on MX's expertise in community health needs, regional care delivery systems, and local market factors throughout the country's most populous and diverse state.

Manifest MedEx is a DxF Qualified Health Information Organization (QHIO), a designation from the state for organizations that have met strict criteria and can help DSA signatories meet their obligations under the DxF.
